

Review this information carefully before making the decision to enroll in summer classes or summer study abroad. To avoid taking on additional debt, Student Registration and Financial Services (SRFS) recommends that you attend summer classes only if absolutely necessary.

Applications must be received by the appropriate application deadline: June 7, 2019

If you want to receive notification of summer aid eligibility prior to the beginning of summer classes, you must submit your application by May 1, 2019.

Applications submitted after deadline will not be accepted and financial assistance will not be available for summer costs.

Eligibility

To be considered for federal or institutional aid to attend summer school, you **must** meet the following criteria:

- Be registered for a minimum of 2 credit units (CU) throughout summer 2019.

1 CU in Summer Session I + 1 CU in Summer Session II

or

2 CU in Summer Session I or 2 CU in Summer Session II

NOTE: Students who are enrolled in fewer than 2 CU and are requesting assistance should still submit this application so SFS can officially determine your options. You will likely be referred to alternative loans.

- Be a continuing student enrolled in a Penn undergraduate program
- Be enrolled in courses that are applied to your degree or a Penn-sponsored study abroad program through the College of Liberal and Professional Studies
- Not be in default on a federal or Penn student loan
- Received need-based financial aid from Penn in 2018-2019

Summer School Information

Financial Aid

Summer financial aid includes primarily loan and limited grant funds. Penn's grant-based policy does not apply to summer financial aid. Just as in the academic year, a family contribution is included as part of any financial aid packages for summer courses. This family contribution is different from, and in addition to, the expected family contribution for both the previous and upcoming academic years.

Federal Work-Study

If you are planning to enroll in classes and also want Federal Work-Study, you should complete the Federal Work-Study application available on the Student Employment website at www.sfs.upenn.edu/seo. You must also submit your 2019-2020 FAFSA.

To Apply

- Review the eligibility criteria and Summer School information on the preceding page.
- Submit the completed Undergraduate Financial Aid Application for Summer School 2019 by the appropriate deadline (June 7, 2019). If you want to receive notification of summer aid eligibility prior to the beginning of summer classes, you must submit your application by May 1, 2019. Applications submitted after deadline will not be accepted and financial assistance will not be available for summer costs.

After You Apply

- Notification** - We will send you an email once your financial aid notice is available. You will be able to review your financial aid through Penn InTouch at <http://www.upenn.edu/pennintouch>.
- Drop/Add** - Complete a revised summer school application if you add or drop courses that will affect the amount of your tuition and fees charged. SFS will recalculate your financial aid eligibility, and produce a revised notification letter. **NOTE: If your final registration is only 1 CU for the summer, you are not eligible for most financial aid assistance.**
- Loan Notes** - Sign your loan note(s) online as soon as possible. You will receive an email with instructions on how to complete this process online. Credit will not be applied to your student account until SRFS receives notification of your signed loan note(s).
 - **Nursing Student Loan** Promissory Notes for Summer Session I must be signed online as soon as possible but no later than July 1, 2019.*
 - **To apply for a Federal Direct Loan** please email stuloans@pobox.upenn.edu
Please include: your full name, PennID, type of loan, loan period and loan amount requested.
The application needs to be completed as early as possible and no later than July 15, 2019.*

*Failure to comply with these deadlines will result in loss of funding

- If you expect a **student account refund**, we strongly encourage you to sign up for direct deposit.
